Policy-Related Activities	 In Brazil, since a monthly fee cannot be charged to participating members, participation in the conferences is controlled through our mailing list. Leadership meetings were held to consider the composition of candidates for upcoming ISPOR Brazil management. These took into account the expansion of geographic decentralization including another Board member positioned in Rio de Janeiro and representatives of the existing members in the Brazilian health system. The current Board has members from helath insurance companies, academia, market consultants and the pharmaceutical industry.
Conferences and/or Chapter Meetings	 August 1-4, 2012, 4th ISPOR Brazil Chapter Conference. There were over 300 attendees with 240 participating in pre-convention courses. The main objectives were to: Provide an environment where researchers, professionals, policy-makers and health care managers can share knowledge nationally; Encourage cooperation and collaboration in pharmacoeconomics and outcomes evaluation of all interested organizations: hospitals, institutions, universities, providers, pharmaceutical and medical supply companies, and hospital and government agencies; Train and improve the technical knowledge of the public present at the event through pre-convention, well-designed courses, with renowned speakers, both experts on the subject and well-trained; and Disseminate and democratize the concept, knowledge of pharmacoeconomics for private and public decision-makers in the municipal, state and federal sectors.
