Training workshops and information related to pharmacoeconomic evaluations.

We added 8 members this year. We were unable to implement all the membership drive plans we had for 2016.

We were unable to execute the planned training for HTA due to inability to raise the funds. However, we continued to maintain contact and encouraged the teaching of Pharmacoeconomics in several pharmacy schools which have been our strongest point in promoting the subject.

There was no research related activity

The chapter was fully represented in a central working expert group developing policies for universal health coverage and in the process successfully achieved the formation of a national committee charged with the responsibility of developing an HTA policy. The work of this HTA committee is affected by the lack of funding.

We were only able to have three executive meetings in 2016 to deliberate on how best to encourage the government to go ahead with the development of the HTA policy.

Our members have presented several posters in ISPOR International meetings in the past but most were not able to attend meetings due to the current hard economic situation where the NGN has been seriously devalued.
