BOOTH EQUIPMENT AND CONFIGURATION

Display materials should be arranged in such a manner so as not to obstruct sight lines of neighboring Exhibitors. Future location penalties will be assessed for Exhibitors who violate the rules.

Inline Booths (Linear Booths)

Inline Booths are 10' x 10' or 10' x 20' units arranged in a straight line. Exhibitors may contract one unit or multiple adjacent units. Neighboring exhibitors may be present on one or more sides. Booth configuration and aisle exposure vary by location. If you are unsure about your booth configuration, location, or aisle exposure, please contact exhibit@ispor.org.

The standard 10' x 10' booth for this conference includes:

- 8' High Back Drape: Black and White
- 3' High Side Rail Drape: Black
- 1 - Booth ID Sign Floor Sticker
- **Please note: Booth packages do not include carpet or electricity**
