


# Better Health WORLDWIDE

Our team works with many databases to identify and acquire the best data for your research needs. Some of our recent work has been with several large claims databases (confidential until published) and with Workpartners Research Reference Database (RRDb) — exclusively available through Better Health Worldwide.



## About the Workpartners RRDb

With data from US employees, spouses, and dependents from 2001—present, the database contains medical and pharmaceutical claims for over 3.6 million employees and dependents (about 5.7 million total lives) from over 500 US private sector employers in the medical, retail, service, manufacturing, transportation, energy, technology, financial, and utility industries.

The RRDb includes:

- Enhanced employee demographics (including self-reported race).
- Job-related employee information (salary, job type, full/part-time status, exempt/non-exempt status).
- Data on employees and their covered dependents (spouses and children) in all 50 states.
- Eligibility and claims information for employees and dependents with dental (>22.6 million claims) and vision (>12.4 million claims) benefits.
- Multi-year self-reported presenteeism survey data.
- The Workpartners RRDb has been used for research in a number of diseases.
- Several manuscripts using the Workpartners RRDb are in submission.

## 5 types of Workpartners RRDb Absence Benefits

- Objective information based on claims (not proxies).
- For each benefit, we track hours missed by employees, and payments made to the employees.
