1. Scientific and Educational Activities.

- 1.1 April, 2012.** Upon the receipt and distribution of 10 copies of the “Health Care Cost, Quality, and Outcomes: ISPOR Book of Terms”, and 10 copies of the new ISPOR Book “Therapeutic and Diagnostic Device Outcomes Research”, organized various discussions on table of contents of the books.
- 1.2 May, 2012.** Preparing a conjoint research with the Serbian Chapter. Translation of a questionnaire into Armenian. The study conducted by Mihajlo B. Jacovljevic, MD, PhD from Serbian Chapter with Armenian investigators- Ara Amirjanyan and Anush Perikhanyan. The topic of the study is the following: SURVEY ON ECONOMIC JUDGEMENT OF HEALTHCARE PROFESSIONALS REGARDING RECOMMENDATION OF VARIOUS MEDICAL PROCEDURES - preventive, diagnostic, and treatment (pharmacological, surgical, physical, and psychotherapeutic), rehabilitating.
- 1.3 June 2-6, 2012.** Poster Presentation by Anush Perikhanya at 17th Annual International Meeting, Washington, DC. The topic of the research was ADMISSION TO CORONARY ANGIOGRAPHIC CATHETERIZATION IN ARMENIA AT NORK MARASH MEDICAL CENTER: CHARACTERISTICS AND OUTCOMES.
- 1.4 November 23-24,** Regional Chapter Educational Seminars on “Designing and Implementing Studies in Health Outcomes”. Invitation of the professor Vahram Ghushchyan from the University of Colorado. The following topics were discussed during the meeting: Outcomes and study designs, Quality of Life, Direct and Indirect Costs, Drug Benefits Design in Armenia. The opening of the meeting was done by the officials from Ministry of Health and the president of YSMU. Short presentation to ISPOR was done by Anush Perikhanyan in Armenian language.
- There were over 150 participants at the first day of the meeting. The second day was dedicated to the improvement of research skills among the ISPOR members who work in the Department of Pharmaceutical Management in Yerevan State Medical University.
