**1. Academic activities:**

8 February, 2011. ISPOR Belarus Chapter, and the members of some pharmaceutical companies ( Association of International Pharmaceutical Manufacturers) organized a training seminar: “ Fundamentals for the formation of the restrictive list of medicines in the Republic of Belarus; Clinical and Economic Expertise”, which has been held in the Crown Plaza Hotel, Minsk, Republic od Belarus. This seminar was considering the implementation of practical methods of pharmacoeconomics in the health care of the Republic of Belarus.

25 May, 2011. ISPOR Belarus Chapter actively participated in the international scientific-practical symposium: “Harmonization of the requirements for pharmacovigilance in the countries of CIS”, organized by the Committee on circulation of drugs of CIS countries business center of economic development; Ministry of Health of the Republic of Belarus, Association of International Pharmaceutical Manufacturers; International Society on Pharmacovigilance (ISoP) ; WHO collaborating centre (Uppsala, Sweden. This symposium was attended by the representatives of regulatory bodies and professional associations of the CIS member states. M. Sura, PhD, head of the laboratory on Modeling and Automation of Drug Software, Russian Ministry of Health Research Institute on Clinical and Economic Assessment, and Sechenov Medical University gave a presentation on

“Creating a system for training the health professionals in the process of the selection the optimal methods for making prescriptions.” The final resolution of the forum contains the appeal to the Ministry of Health of the Republic of Belarus on the use of procedures for Pharmacanalysis to compile the restrictive lists of medicines at all levels of Public health.

**2.Promotional activities:**
