Activities	This was a course that took place on November 21/22 of 2011, with the participation of national and international specialists such as Paul Kind from York, UK and Manuel Espinoza from Chile. The following were some of the topics covered during the workshop: -Measuring health outcomes: about concepts to practice -The development and current status of EQ-5D - Health Assessment
	The Colombian Chapter academic lecture took place on September 1, 2011, and was conducted by Julio Castañeda. It was about Regulatory Regime and competitiveness in Colombia; also, David Bardey spoke about the drug price regulation.
Policy-Related Activities	 * Meetings with the Ministry of Health and Social Protection in order to talk about training programs of HTAs, establishment of the Evaluation Institute of Colombian Technologies, guidelines of clinical practice, benefits plan, and how we can propose improvements to those components. We participated together with the main universities of Colombia, the Inter-American Development Bank (IDB), Pan American Health Organization (PAHO), and National Institute for Health and Clinical Excellence (NICE), in order to issue concepts and recommendations on the Ministry's matrices to provide a policy on the Health Regulatory Commission. Additionally, we had active participation in the discussion groups of the National Drugs Policy. * Meetings with the Health Regulatory Committee, in order to provide feedback with them about the process being managed to update the Mandatory Health Plan. * A reunion was conducted with the Health Regulatory Commission, with the aim of providing feedback with concepts, and assisting them in the process they are carrying out to update the Mandatory Health Plan (POS).
