The monthly chapter meetings have an important role in education experts from different fields (physicians, pharmacists, economists etc.) who are interested in health economics. In addition, students from different universities frequently attends these open meetings. The selected topics are usually discussed from different perspectives, since the speakers usually have different backgrounds.

**Chapter's accomplishments in 2017 with regard to research.**

The annual Hungarian Health Economics Congress, and the monthly chapter meetings provide a platform for chapter members and also to others who are interested in health economics to present their recent research. Also chapter members took part in international collaborative ISPOR research projects. Several members are participating in ISPOR Special Interest Groups (e.g. on Multi-Criteria Decision Making, Patient Adherence, Biosimilars or Nutrition)

**Chapter's accomplishments in 2017 with regard to policy-related activities.**

The latest version of the Hungarian Pharmacoeconomic Guideline was published in early 2017, with several Chapter members among its co-authors. At the monthly meetings policy perspective of the discussed topic is frequently presented and also several meetings were held in governmental institutions where policymakers were present for the discussion.
