Activities / Accomplishments	Summary
Scientific / Educational Activities	Several publications were made in journals and other serials on the pharmacoeconomics principles and conference news of ISPOR. The chapter newsletter is popular, subscribed by more than 3000 health care professionals through email and it is uploaded every month to the chapter page in ISPOR website. Dr. Y. Padmanabha Reddy and Dr. Dixon Thomas attended ISPOR 5 th Asia Pacific Conference in Taipei. Dixon worked as reviewer for two ISPOR conferences. One research paper was contributed to <i>Value in Health Regional Issues</i> - Asia. Four project works started in the area of pharmacoeconomics.
Policy-Related Activities Conferences and/or Chapter	As a pilot scale we focused on policy-related drug procurement changes in RDT Hospital, Anantapur by doing Essential Drug List revision and by doing ABC Analysis. The future focus will be on policy recommendations in district level, state level and national level. International Conference on Pharmacoeconomics and Good Pharmacy Practice on October 13-14, 2012.
Meetings Membership Development	We started with a local membership drive and expanded step by step. Conferences and communications we make help in getting membership. At the end of 2012, we started active promotion of membership in our professional network. We had enrolled 124 members in 2012 from June (month of the chapter's inception).
