Scientific / Educational Activities	1 day seminar was held in the Lin regional clinic of Clalit Health Services in Haifa. During the seminar, ISPOR-Israel members (Shmuel Klang, Oren Shavit, Moshe Leshno, Mordi Rabinovich, and Dan Greenberg) presented various topics on methods for economic evaluations and budget impact analysis.
Conferences and/or Chapter Meetings	The 3 rd Annual Conference of ISPOR-Israel was held on March 10-12, 2010. Main topics included: personalized medicine and preventive medicine. Among the five distinguished speakers from abroad were: Peter Neumann from Tufts Medical Center, Dennis Van Liew from Pfizer, Jim Vaughn from Genomic Health, and Koen Torfs from Janssen-Cilag. A short course on Pharmacoeconomics for Decision-Makers was delivered by Lorne Baskin. Over 170 participants attended the conference.
