Dear ISPOR Board of Director,

I wish to ask you for recognition of ISPOR Italy-Milan Chapter. The founding members of the prospective Chapter include more 109 researchers, professionals and practitioners with different backgrounds, including health economists, clinicians, pharmacologists, hospital and public health pharmacists, pharmaceutical company employees, device company employees, consultants, and working in different organizations, including academia, hospitals, regional/local health authorities, pharmaceutical companies research centers, and health care organizations.

ISPOR Italy-Milan Chapter members include representatives of patients' associations and presidents of many scientific societies. Given the regional-based organization of the Italian NHS, the list includes colleagues active in different regions of Italy, covering Northern and Central Italy, including Piedmont, Lombardy, Veneto, Friuli Venezia Giulia, Trentino Alto Adige, Emilia Romagna, Tuscany, Umbria, Marche, Lazio, Campania, Puglia, Basilicata, Sardinia and Sicily, covering more than 90% of the population of Italy. The Chapter's name refers to Milan, because of the chapter's office and not because of the geographic representation of the members, which is wider.

Since ISPOR is a member-driven organization, we have identified five members who will act as interim and short term Executive Committee, with the aim of organizing the elections of the Executive Committee. Elections will be organized during the first meeting of ISPOR Italy-Milan Chapter, which will be held within 4 months from the date of its constitution, to allow potential new members to join the Chapter and to actively participate in elections. The interim short-term Executive Committee will accordingly serve as Nominations and Elections Committee. The five members are identified on the basis of ISPOR long and active membership, contribution to ISPOR activities, completion and reception of significant charges, duties and awards by ISPOR, as well as on the willingness to take the charge. Until the elections, the five members will act as an Executive Committee of the Chapter.

ISPOR ITALY-MILAN CHAPTER CONSTITUTION

Article 1: Name

The name of this organization is the International Society for Pharmacoeconomics and Outcomes Research herein referred to as ISPOR Italy-Milan Chapter.

Article 2: Mission

The mission of the ISPOR Italy-Milan Chapter is to:

- Provide an environment where researchers, health care practitioners, and decision-makers interested in pharmacoeconomics and outcomes research can share knowledge at a country level.
- Serve as a bridge in bringing together country researchers, health care practitioners, and decision makers interested in pharmacoeconomics and members of the pharmaceutical industry, health-related organizations, and academia.
- Act as a resource at a local level for individuals interested in pharmacoeconomics and outcomes research.
- Provide an opportunity for country-specific chapter members to become more familiar with the activities of ISPOR as well as participate in its activities.

Article 3: Affiliation

The ISPOR Italy-Milan Chapter will maintain affiliation as a component chapter of the International Society for Pharmacoeconomics and Outcomes Research (ISPOR).

Article 4: Membership

Active membership is open to any individual Italian, or living in Italy or in Italian-speaking countries, interested in the Society and who supports the mission of the Society. The eventual yearly dues for local members will be defined yearly by the ISPOR Italy-Milan Chapter. There will be an ongoing membership recruitment program to encourage membership into the Chapter as well as the Society.

Article 5: Organization

The ISPOR Italy-Milan Chapter shall be composed of: founding members (members who join ISPOR Italy-Milan Chapter within the date of the Congress) and full members (members that submit a written request signed by the applicant stating their name, nationality, age and address, and signed by two full members as presenters). Founding members are full members.

Leadership:

The ISPOR Italy-Milan Chapter Executive Committee is composed of the following officers: President, Past-President, President, Presi

- The first interim Executive Committee is described in Article 12.
- The active members of ISPOR Italy-Milan Chapter should elect the ISPOR Italy-Milan Chapter Executive Committee officers.
- Elections should be held at the same time each two years according to the rules and procedures outlined in Article 8.
- Within the Executive Committee all components should be represented: academia, consultancies, pharmaceutical industry, device industry, public pharmacists/ pharmacologists, practicing physicians.
- The election committee should base nominations accordingly.
- The ISPOR Italy-Milan Chapter executive officers should hold their respective positions for a term of three years, or for the remainder of a term when filling a vacancy.

Article 6: Procedures

- 1. ISPOR Italy-Milan Chapter should be governed by this constitution.
- 2. ISPOR Italy-Milan Chapter should be a recognized organization in the country and comply with local governmental policies.
- 3. ISPOR Italy-Milan Chapter should hold general meetings during the year. Special executive meetings should be held at the discretion of the executive officers.
- 4. Any member or officer of ISPOR-Milan Chapter may initiate a constitutional amendment. Procedures for amending this Constitution are outlined in Article 9.
- 5. Each ISPOR-Milan Chapter executive officer or member should exercise one vote.
- 6. The Ordinary General Assembly a proposal of the ISPOR Italy-Milan Chapter Executive Committee shall fix fees payable by members, as collection and any changes in its size.
- 7. In the case that the Executive Committee fix fees payable by members, the Member who ceases to pay the amount of two installments will be invited to make payment within fifteen days following the request and if it does not, membership will be revoked.
- 8. The members will ultimately be discharged for the following reasons:
- For voluntary resignation. In this case again to enter will require the agreement of the General Assembly, having examined the causes that led to the voluntary resignation.
- Those who perform an act considered by the Executive Committee, within or outside the Association, to injure the reputation or prestige of this, and those otherwise prejudice the interests of the same.
- Those who disobey the decisions of the General Assembly or the Executive Committee.

Article 7: Duties of Officers

Each officer should be elected for a term of three years.

President

The President of ISPOR Italy-Milan Chapter should:

- 1. Conduct and preside over all meetings of ISPOR Italy-Milan Chapter.
- 2. Represent ISPOR Italy-Milan Chapter when called upon to do so.
- 3. Appoint an individual to any office that becomes vacant subject to the Executive Committee approval.
- 4. The office of the President should be open to any member of ISPOR Italy-Milan Chapter.
- 5. Provide a report of activities and financial transaction to the ISPOR Board of Directors annually.

President-elect

The President-elect of ISPOR Italy-Milan Chapter should:

- 1. Succeed to the office of the President upon completion of a two years term of President-elect.
- 2. Conduct and preside over all meetings of ISPOR Italy-Milan Chapter in the absence of the President.
- 3. Assist the President with the responsibilities of ISPOR Italy-Milan Chapter.
- 4. The office should be open to any member of ISPOR Italy-Milan Chapter.

Past-President

The Past-President should:

- 1. Conduct and preside over all meetings of ISPOR Italy-Milan Chapter in the absence of the President and President-Elect.
- 2. Assist the President with the responsibilities of ISPOR Italy-Milan Chapter.

Secretary and Treasurer

The Secretary of ISPOR Italy-Milan Chapter should:

- 1. Record the minutes of ISPOR Italy-Milan Chapter meetings. An official copy of the minutes should be kept in the ISPOR Italy-Milan Chapter records and a copy emailed to the regionalchapter@ispor.org.
- 2. Handle ISPOR Italy-Milan Chapter correspondence as necessary.
- 3. Keep and maintain the ISPOR Italy-Milan Chapter records.
- 4. The office should be open to any member of ISPOR Italy-Milan Chapter.

The Treasurer should:

- 1. Keep and make available to the members of ISPOR Italy-Milan Chapter and the ISPOR Board of Directors a record of all monies received and spent by ISPOR Italy-Milan Chapter.
- 2. Report the financial status of ISPOR Italy Milan Chapter at meetings.
- 3. Assist the President in the preparation of an annual budget.
- 4. Oversee the financial activities of ISPOR Italy-Milan Chapter.
- 5. The office should be open to any member of ISPOR Italy-Milan Chapter.

Directors

The number of Directors will be indicated by the President. In the first instance five Directors will be elected

The Directors should:

- 1. Assist the President with the responsibilities of ISPOR Italy-Milan Chapter.
- 2. Perform duties as assigned by the Executive Committee.

Article 8: Election Procedures

- 1. The active members of ISPOR Italy-Milan Chapter should elect the ISPOR Italy-Milan Chapter executive officers.
- 2. The ISPOR Italy-Milan Chapter Executive Committee (President, President-elect, Secretary, Treasurer, Directors) should appoint an Election Committee.
- 3. The Election Committee should solicit nominations.
- 4. Elections should be held.

5. The new ISPOR Italy-Milan Chapter President should inform the ISPOR Board of Directors of the newly elected officers. The names of the newly elected officers should be sent via email to: regionalchapter@ispor.org.

Article 9: Termination of Chapter Membership

Members will be caused to leave the Chapter for any of the following reasons:

- 1. Action that could be considered objectionable and against the interests and purposes of the chapter. The member would receive a notice with the report of the Executive Committee; there would be an open and secret voting with qualified majority.
- 2. In the case of calling for payments, for lack of two installment payment.
- 3. Voluntary resignation

Article 10: Amendments

- 1. Any active member or officer of ISPOR Italy-Milan Chapter may propose constitutional amendments.
- 2. A proposed amendment to this or new Constitution should become binding after receiving a two-thirds majority of the total voting membership of ISPOR Italy-Milan Chapter.
- 3. Any amendments should be sent via email to: regionalchapter@ispor.org.

Article 11: Indemnification

ISPOR Italy-Milan Chapter will indemnify ISPOR from liability for injury or damage, cost or expense resulting from or which arises out of or in connection with the use by ISPOR Italy-Milan Chapter of the ISPOR name, logo, or arising from the relationship or affiliation between the parties.

Article 12: Transitional Arrangements

- 1. In consideration of the fact that ISPOR-Milan Chapter is a member-driven organization and in order to guarantee full democracy in representation, the President, President-elect, the Secretary, the Treasurer, and the remaining members of the Executive Committee are not indicated in this act. They will be elected directly by the members of ISPOR Italy-Milan Chapter during the first ISPOR Italy-Milan Chapter Congress, which will be held before June 2014.
- 2. Five members of the ISPOR-Milan Chapter will be in charge of organizing the Congress and elections, thus serving as interim Executive Committee and Election Committee as described in Article 8.
- 3. The five members are identified on the basis of ISPOR long and active membership, contribution to ISPOR activities, completion and reception of significant charges, duties and awards by ISPOR, as well as on the willingness to take the charge. During the period between the constitution and the elections, the three members will act as Executive Committee.
