<p>Scientific / Educational Activities</p>	<p>EUPATI training Program: partnership between Italian Pharmaceutical Agency (AIFA) and ISPOR Italy-Rome Chapter. The collaboration foresees the relevance, evaluation, quantification of the impact of the population regarding the EUPATI project.</p> <p>Estimation of the Italian QoL coefficients based on the EQ-5D model. Results from a pilot study in Italy: To estimate the Italian QoL coefficients and to create an algorithm which can be used by decision makers dealing with HTA in Italy.</p> <p>HTA for decision makers in public health immunization: organize a multidisciplinary working group of experts that collect HTA evaluations in the area of vaccine prevention, evaluate the actual use of such evaluations in the decision-making processes, identifying critical issues of transfer of such evaluations to all actors involved.</p> <p>Measure, evaluate and improve the pathway of the diabetic patient in Italy: it offers an analysis of burden of disease in the diabetic condition in order to propose a re-engineering of care pathways in order to maximize the use of the various technologies available. The study is based on analysis of real data and previously published models specifically national health context.</p> <p>Social and Indirect Costs: the Economic Burden on the Social Security System Pensions for Musculoskeletal Disorders in Italy: A better prescription appropriateness and rapid access to innovative treatments (Italy, among the EU Countries, is the one with the greatest delay in access) would reduce the costs incurred by the social security system accompanied by an improvement on the effectiveness of interventions.</p>
