Chapter's accomplishments in 2016 with regard to research

HTA for decision makers in public health immunization: organize a multidisciplinary working group of experts that collect HTA evaluations in the area of vaccine prevention, evaluate the actual use of such evaluations in the decision-making processes, identifying critical issues of transfer of such evaluations to all actors involved. Organization of regional events to present research results to policy makers. (Methodological paper was published in an international journal indexed). Measure, evaluate and improve the pathway of the diabetic patient in Italy: it offers an analysis of burden of disease in the diabetic condition in order to propose a re-engineering of care pathways in order to maximize the use of the various technologies available. The study is based on analysis of real data and previously published models specifically national health context. Social and Indirect Costs: the Economic Burden on the Social Security System Pensions for Musculoskeletal Disorders in Italy: A better prescription appropriateness and rapid access to innovative treatments (Italy, among the EU Countries, is the one with the greatest delay in access) would reduce the costs incurred by the social security system accompanied by an improvement on the effectiveness of interventions. (The study was published in an international journal indexed.)
