Did your Chapter contribute to any health policy-related activities on national/regional level?	A comparative economic evaluation between the oral chemotherapy 'CAPOX' and the IV chemotherapy 'mFOLFOX6' as the adjuvant treatments of chemotherapy for colorectal cancer (CRC) in Qatar. This study is in support of the recent 2018 changes in the policy of Hamad Medical Corporation (HMC), where the cost of 'oral' chemotherapies for non-Qataris is now covered by the state. The oral chemotherapy CAPOX regimen (capecitabine, oxaliplatin) is considerably more expensive to purchase than the IV mFOLFOX6 (5-fluorouracil, leucovorin, oxaliplatin). CAPOX, however, is associated with lesser hospitalisation and adverse drug reactions compared with mFOLFOX6. Hence, as a direct response to a request by decision-makers at the National Center for Cancer Care and Research (NCCCR), which is a member of HMC, Ahmad evaluated the cost-effectiveness of CAPOX versus mFOLFOX6 in the NCCCR. The evaluation assessed which of the two regimens costs less in overall per outcome, going beyond the acquisition costs of drugs to also evaluate the secondary costs associated with hospitalisation and adverse events.
