<u>12th Open Meeting (school-Seminar) of Formulary Committee.</u> <u>Health Care Reform: Economic Feasibility or Social Responsibility</u>?



In Yaroslavl, 25-28 June 2014, XII Open Meeting (School-Seminar) of Formulary Committee "Health care reform: economic feasibility or social responsibility?" was held.

- Drug provision to preferential categories of citizens (O.V. Minakova).
- Multicriterial decision-making (K. Kolasa, professor of Warsaw Medical University),
- Polypharmacy (D. Sychev, member of Formulary Committee),
- New medicine approaches to alcoholism (A.A. Mukhin, company Lundbeck, T. Agibalova),

- Problems with generics and Biosimilar drugs (A. Yegorov, vice-chairman of Formulary Committee),
- Treatment of breast cancer in Far East of Russia (S. Suleymanov, member of Formulary Committee, president of ISPOR Far East Chapter),
- Use of statins in medical practice (V. Vlasov, member of Formulary Committee, president of Russian chapter of Cochrane Collaboration),
- Modernization of healthcare in Russia (V. Baev, member of Formulary Committee),
- ISPOR CEE Network activity and assessment of non-medical technologies (L. Krasnova, Executive Director of Russia ISPOR chapter)
- Comparison of pricing in Russia in regards to the other countries (M. Holownia, Director of Economics of Russia ISPOR Chapter).

Besides the very interesting agenda, the meeting attendees have been also sightseeing cities of Yaroslavl, Rostov, and Tolga Monastry.
