Chapter activities can be summarized as per follows:

2009 Promotional activities:

- 1) Established closer collaboration ties with appropriate decision makers at the Ministry of Health, Republic Institute of Health Insurance, Medicines and Medical Devices Agency of Serbia, Serbian Medical Chamber, The Pharmaceutical Chamber of Serbia, Pharmaceutical Society of Serbia pharmacoeconomics section, Faculty of Pharmacy- University of Belgrade, Medical University of Novi Sad and Medical University of Kragujevac.
- 2) March 2009 1st Serbian International Health Economics conference held "Health economics in the context of health care system. Experience from Central, East and South Europe (Balkans)" which promoted formation of ISPOR Chapter Serbia and ISPOR society held in Belgrade, Serbia. 150 attendees present. All attendees from Serbia received automatically local membership for 2009 by registering for the conference (100 members).

Legal activities:

- 1) December 2009 February 2010 Due to new Serbian law requiring all societies to re-register with newly created government agency to deal specificaly with the societies, we entered re-registration process. In the process, the society statute needed to be revised and conformed to the new re-registration process guidelines.
- 2) December 2009 Elections were held. Vladimir Zah (President) and Natasa Bogavac (Secretary) were re-elected (2nd & final term). Dragana Atanasijevic was elected to Vice-President post.
