1.	Presentation of chapter activities	
1.	Meeting started at 1930 hrs. ISPOR-Singapore President Allen Lai informed the members that there were two educational events carried out since the last AGM in June 2016. In addition, a LinkedIn Professional Group was created in 2016 and a survey to gain knowledge of members' interests on ISPOR-S' activities was conducted. Out of 46 votes casted, 19 have responded. The top 4 areas of interests among 19 responses are: value-based pricing (26%), precision medicine (17%), network meta-analysis (13%), and patient-reported outcomes (11%). 	Allen also shared that there is a growth in membership size from 47 to 85 members as at June 2017. Till the point of this meeting, there are eighty five (85) members in ISPOR-S in which 21% from academics, 15% from government agencies, 64% from healthcare industries and consulting firms.

	Joanne Yang shared that having a workshop is a good idea and would prefer it to be in a more interactive style. Huong Nguyen shared that it would be good to conduct workshops in the evening or after working hours, and topics could be on how policies would translate to the work of or affect healthcare professionals. Michael Lim suggested to recruit hospital officers to join ISPOR-S as members. He also suggested the aim of the events could bridge the gaps in Health Technology Assessment. Mohammad Talaei shared that it is important to have a platform for learning and he is interested in topics on Precision Medicine and Health Technology Assessment.	
	Luo Nan shared that it is great to have social media being used to increase awareness of ISPOR-S. It is also encouraging to see the growth in membership size of ISPOR-S. He also suggested ISPOR-S to consider organizing a conference in future.
