Accomplishments in policy 2016. In July 2016 ISPOR SA Chapter held its first formal meeting with the South African Pricing Committee. The Pricing committee is a statutory committee established in terms of the Regulations of the Medicines and Related substances Act (101 of 1965). The Pricing Committee makes recommendations to the Department of Health on the regulation of medicines prices in the private health sector in South Africa. This includes implementation of the country's guidelines for pharmacoeconomic submissions, published in 2014. The July meeting between ISPOR SA and the Pricing Committee took place during the Committee's regular monthly meeting on 23rd July. ISPOR SA Presented its mission, vision, membership make-up and plans for its upcoming conference and requests for how the organization can work with the Department of Health and the pricing Committee to further pharmacoeconomics and the implementation of the guidelines. The Pricing Committee was receptive to further partnering and supportive of ISPOR SA's plans. The chair requested that ISPOR SA formally include the pricing committee in all planning for educational and policy activities going forward so that we can find ways to better work together for the betterment of pharmacoeconomic evaluations in the country.

She also presented in the ISPOR Africa Network Forum in a session entitled "THE **ECONOMIC BURDEN OF COUNTERFEIT MEDICINES IN** AFRICA: SITUATION ANALYSIS AND PROPOSED SOLUTIONS". The moderator for this session was Dr Mahmoud Diaa Elmahdawy, President, ISPOR Egypt Chapter. This session was held on Monday, 31 October at 18:15-19:15, and Ilse's paper was entitled, "Economic Burden of Counterfeit Medicine in South Africa: Situation Analysis and Proposed Solutions". She also presented on behalf of Dr Anthony Waka Udezi, the President of ISPOR Nigeria, on "Fake and substandard drugs: some practical solutions from Nigeria". Dr Elmahdawy presented on the situation regarding counterfeit medicines in Egypt and also in Ghana. In addition, Ilse was a poster judge on Monday morning and presented four posters during the conference.
