## Annual Report of ISPOR-Thailand Chapter, 2006

After International Society of Pharmacoeconomics and Outcomes Research (ISPOR) Thailand Chapter was founded in 2005, a few meetings were held. Primary objective of the meetings was to fulfill missions proposed by the chapter. The missions include 1) To provide an environment for knowledge sharing among researchers, healthcare practitioners, and decision-makers interested in pharmacoeconomics and outcomes research 2) To serve as a bridge in bringing together Thai researchers, healthcare practitioners, and decision-makers interested in pharmacoeconomics and members of the pharmaceutical industry, health-related organizations, and academia. 3) To act as a resource at a local level for individuals including students interested in pharmacoeconomics and outcomes research 4) To provide an opportunity for Thailand chapter members to become more familiar with the activities of ISPOR as well as participate in its activities.

### Conclusions:

ISPOR Thailand Chapter was founded at the end of 2005. It has grown up relatively fast. It has more 50 members across the country. The first ISPOR Thailand Chapter inaugural meeting was held in September with a great success. A number of health care professionals, including policy makers and practitioners, attended the meeting. They were from both public and private sectors. A roadmap of pharmacoeconomics in Thailand was proposed for action. Some Pharmacoeconomics Networks were established and people in the network have contributed their work at the national level.

However, the chapter is at the beginning phase. All of the chapter committee obtained supports from their own institutions to work for the chapter. To date, the chapter itself does not have fund for activities. This problem needed to be solved to strengthen the chapter sovereignty.
